

Southwest Texas Junior College respectfully supports the \$2.03 billion formula funding request submitted by the Texas Association of Community Colleges (TACC) in its letter to the Legislative Budget Board and the Governor's Office, Budget Division. State support remains critical to the district as it continues to fulfil its statutory role and mission to offer vocational, technical, and academic courses for certificate, transfer, and degree programs. Together with Texas' other 49 community college districts, we will continue do much of the heavy lifting in the state's efforts to achieve the Building a Talent Strong Texas strategic plan. Expanded state investments in community colleges will support dual credit courses that give high school students an early start in postsecondary education; initiatives to recruit un- credentialed Texans and support them through graduation; and the creation and expansion of programs built on the skills necessary for gainful employment and Texas' continued economic growth.

As evidenced by historic analysis, the results of the booming economy have had negative impact on our enrollment which is compounding our recovery from the Covid-19 pandemic. Historically when the economy is strong and unemployment is low, community college enrollment declines. We urge the Legislature to support our funding requests in light of this phenomena, in order to not negatively impact our programs and set us back from continuing to provide these programs.

With the funding from the State of Texas, the College will be able to address the unprecedented challenges of the post pandemic environment as well as the safety and mental health concerns that we must address from the lessons learned from the Robb Elementary shooting.

The College continues to enhance partnerships with public school districts, embrace transfer pathways, and strengthen our relationship with Sul Ross State University. The College is the fabric that unites higher education for our region of Southwest Texas.
